

### **REPORTING**

# **AWARENESS**

### SAFE2SPEAKUP STUDENT APP

The Safe2SpeakUP app is the student companion to CrisisGo's safety app, allowing stuents to play their role in school safety. Often used as the first step in the "Early Warning and identification" process, students can:

- Report bully-related activity.
- Report threats and concerning behaviors.
- Disclose those at risk of suicide.
- Submit safety tips about incidents at schools.
- Access safety resources during an emergency event.
